

RELEASE, HOLD HARMLESS AND INDEMNIFICATION AGREEMENT

In consideration of being permitted to participate in United States Coast Guard Auxiliary's public education, On Water Training, conducted by the United States Coast Guard Auxiliary, releasor, for _____, and releasors, legal representatives, heirs and assigns, hereby releases, waives and discharges the United States and any Division thereof, the United States Department of Transportation, the United States Coast Guard, the United States Coast Guard Auxiliary, its officers, members and employees, here referred to as releasees, from all liability to the releasor, _____, and releasors legal representatives, heirs and assigns, for any and all loss or damage, and any claim or damages resulting therefrom, on account of injury to releasor's person or property, even injury resulting in death of the releasor, whether caused by the negligence of releasees or otherwise while the releasor is participating in this program.

Releasor agrees to indemnify the releasees and each of them from any loss, liability, damage or cost they may incur due to the participation of releasor, whether caused by the negligence of the releasees or otherwise.

Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of releasees or otherwise while underway, or dockside, or at any time whatsoever.

Releasor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the law and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
